On Thursday the 10th of August the UNFS gathered in the Institute Hall in Booleroo Centre for a full-day expo. The theme of the day was "Getting more from crop rotations: cereals, the new UN break crop?". Attendees were given a series of presentations on pulse growing and marketing, pesticide regulations, recent trends in the wool industry and paddock temperature sensors. There was also a visit to a SARDI break crop trial site in the afternoon. Approximately 80 people attended the day.

- The 2017 UNFS Members Expo received very positive feedback.
- The morning session included presentations on growing pulses in the low rainfall zone, pulse grain marketing, pesticide regulations and practical tips for farmers, advances and trends in the wool industry, and temperature sensors and weather stations.
- In the afternoon, attendees travelled to a SARDI break crop trial site near Wilmington.
- Approximately 80 people attended the day, including many returning UNFS members as well as some new ones.
- The event was made possible through funding from SAGIT, GRDC and our valued sponsors.

Overall Performance

The 2017 Members Expo was attended by approximately 80 people in total. The day was a huge success, with all the presentations as well as the field trip receiving highly positive feedback.

All members of the UNFS board and operations committee were involved in putting the day together. Outgoing UNFS chairman Barry Mudge and project officer Hannah Mikajlo gave a brief welcoming presentation. Speakers on the day included farmer and consultant Chris Crouch, Jamie Koch from Pinnakle Agri Business Services, consultant Peter Cousins, Adrian Dewell from Landmark Jamestown and Leighton Wilksch from Agbyte. SARDI representatives including Larn McMurray and Jenny Davidson led attendees through the SARDI break crop research site and explained the different trials.

- Recent advances and trends in the wool industry
- Paddock temperature sensors and weather stations

At the break crop site in the afternoon, SARDI representatives explained and discussed the trials, including...

- Many different varieties of field peas, beans, lentils, lupins, vetch, chickpeas and canola
- Different nutrition and fungicide management treatments

After the event, UNFS released a media statement (attached), which was published in the Jamestown Journal and the Flinders News.
